- 2 According to the requirements of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the revenue from operations for the quarter ended June 30, 2017, quarter and half year ended September 30, 2016 and year ended March 31, 2017 are inclusive of excise duty. Goods and Service Tax ("GST") has been implemented with effect from July 1, 2017 which replaces excise duty and other taxes. As per Ind AS 18, the revenue for the quarter ended September 30, 2017 is reported net of GST and accordingly, is not comparable to that extent with other published periods.
- 3 The shareholders of the company have approved dividend of Re. 0.30 per share for the year ended March 31, 2017 in the Annual General Meeting held on August 8, 2017. Accordingly, the company has paid dividend of Rs. 432.44 lacs (including dividend distribution tax of Rs. 73.14 lacs) during the guarter ended September 30, 2017.
- 4 The board of Directors has recommended an interim dividend of Re. 0.25 per share. (Face value of Re. 1/- each).
- 5 The company has presented segment information in the Consolidated Financial Statement and accordingly in terms of paragraph 4 of Ind AS 108 Operating Segments, no disclosure related to segments are presented in this standalone financial results.
- 6 Tax expenses includes current tax and deferred tax.
- 7 The figures for the previous periods have been regrouped / reclassified wherever necessary to correspond with the current period's classification.

- 1. We have reviewed the accompanying statement of unaudited standalone financial results of Astral Poly Technik Limited (the 'Company') for the quarter ended 30th September 2017 and year to date from April 1, 2017 to September 30, 2017 (the "Statement") attached herewith, being submitted by the Company pursuant to the requirements of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, read with SEBI Circular No. CIR/CFD/FAC/62/2016 dated July 5, 2016.
- 2. The preparation of the Statement in accordance with the recognition and measurement principles laid down in Indian Accounting Standard 34, Interim Financial Reporting (Ind AS 34) prescribed under Section 133 of the Companies Act, 2013 read with Rule 3 of Companies (Indian Accounting Standards) Rules, 2015 read with SEBI Circular No. CIR/CFD/FAC/62/2016 dated July 5, 2016 is the responsibility of the Company's management and has been approved by the Board of Directors of the Company. Our responsibility is to express a conclusion on the Statement based on our review.
- 3. We conducted our review in accordance with the Standard on Review Engagements (SRE) 2410'Review of Interim Financial Information Performed by the Independent Auditor of the Entity'
 issued by the Institute of Chartered Accountants of India. This standard requires that we plan and
