










PIPING BUSINESS - RATIOS, CAPACITY & PRODUCTION




DEBT/EQUITY RATIO

CAPACITY UTILIZATION (IN '000 MT)












SEAL IT-UK & USA NET REVENUE



ADHESIVE TOTAL-NET REVENUE













SEAL IT-UK & USA EBIDTA




ADHESIVE TOTAL-EBIDTA



GROUP REVENUE BREAKUP - FY 18 -19







CONSOLIDATED (INR MN.)



NET REVENUE








CONSOLIDATED (INR MN. EXCEPT EPS)



KEYTAKE AWAY



- In FY19 Rex numbers are considered from July 10, 2018 onwards
- The full year numbers of Rex will be considered from next year
- Infra product expansion (Rex) will be completed in July 2019
- Hosur: Depot building completed and operational, production building completed, machinery installation is going on, expected to be completed by July 2019
- The company has purchased land approx. 100,000 Sq. yard to establish manufacturing facility in Bhubaneswar, Odisha (East India). Construction will start in current year, plant will be ready by September 2020
- Rescue Tape import started from USA plant (Seal It). Initially response is encouraging in Resinova channel

OPPORTUNITIES IN PIPING INDUSTRY



- Initiatives like "Housing of All by 2022" and "Smart Cities Mission" is driving residential development and will direct growth of the Infrastructure Sector.
- 100% FDI is permitted through the Automatic route in the Infrastructure Sector.
- Government has sanction 37 Lacs houses in the urban areas for construction. In NHB a dedicated affordable Housing Fund to be established.
- The Government has proposed to complete construction of 1 Cr houses by 2019 in the rural areas under the Prime Minister Awas Scheme.
- In India Pipes & Fitting Market approx. Rs. 30,000 Cr..

OPPORTUNITIES IN PIPING INDUSTRY



- The Government targets to builds approx. 67 lacs urban toilets by October 2019 under Swachh Bharat Mission.
- In the recent budget, Pradhan Mantri Awas Yojana (PMAY) has received allocation of Rs. 25,853 Cr.
- Government programs like PMKSY, PMAY-U, PMAY-G and AMRUT & Smart City are supportive to the industry.
- Under AMRUT, Smart City Development, HRIDAY Total 482 Cities with population above one lacs have been indentified, Availability of tap with assured water supply and sewerage connection in very house.
- Real Assets sector market size is expected to contribute 13% of the country's GDP by 2025. Expected to touch Rs. 12.6 Lacs Crore in 2020

OPPORTUNITIES IN INFRASTRUCTURE



- Under Pradhan Mantri Gram Sadak Yojana, government has allocated Rs. 19000 Cr. For 2019-20
- Construction of rural road has been tripled under Pradhan Mantri Gram Sadak Yojana.
- Budget allocation to highways increase to nearly Rs. 83000 Cr.
- Government has announced development of 1 lacs villages into digital villages over the next 5 years.
- In Interim budget, government apportioned a mammoth budgetary support of Approx. Rs. 4.56 Lacs Cr for infrastructure for FY 2019-20. This includes roadways, railways, shipping and aviation.
